#### ARTICLES OF INCORPORATION

# OF PROSPECT VILLAGE PROFESSIONAL OFFICE CONDOMINIUMS COUNCIL OF CO-OWNERS, INC.

The undersigned Incorporator has executed these Articles of Incorporation for the purpose of forming and does hereby form a non-stock, non-profit corporation under the laws of the Commonwealth of Kentucky in accordance with the following provisions:

## **ARTICLE 1**

#### NAME

The name of this corporation is "Prospect Village Professional Office Condominiums Council of Co-Owners, Inc."

## **ARTICLE II**

#### **PURPOSES**

The general purpose of this corporation is to be the "Council of Co-Owners" as defined in the Kentucky Condominium Property Law, and as amended, for the operation and administration of "Prospect Village Professional Office Condominiums", a condominium established in Prospect, Jefferson County, Kentucky, pursuant to the provisions of the Kentucky Condominium Property Law.

#### ARTICLE III

#### **POWERS**

This corporation shall have all the powers conferred upon a non-stock, non-profit corporation organized under the provisions of Chapter 273 of the Kentucky Revised Statutes, as amended:

all of the powers conferred upon the Council of Co-Owners under the provisions of the Kentucky Condominium Property Law and, as amended; all of the powers conferred upon the corporation in the Master Deed for "Prospect Village Professional Office Condominiums" which document is recorded by the Incorporator in the Office of the Clerk of Jefferson County, Kentucky; and, all of the powers necessary and proper, convenient and desirable in order to fulfill and further the purpose of this corporation.

## **ARTICLE IV**

## **DURATION**

The duration of this corporation shall be perpetual or until the corporation is sooner terminated by the members in the manner prescribed in Chapter 273 of the Kentucky Revised Statutes.

### ARTICLE V

#### REGISTERED OFFICE AND REGISTERED AGENT

#### **MEMBERS**

All persons who are owners of units in "Prospect Village Professional Office Condominiums"

shall be members of this corporation and the membership in this corporation shall be limited to such owners of such units. Membership in the corporation shall terminate when a person or other entity is no longer the owner of a unit. Subject to the foregoing, admission to and termination of membership and the voting rights of members shall be more particularly governed by the Master Deed and the By-Laws for "Prospect Village Professional Office Condominiums."
