WHEREAS, on December 8, 2014, Declarant imposed and declared upon Section 2, and made Section 2 subject to, that certain Declaration of Covenants, Conditions and Restrictions of record in Deed Book 10336, Page 125, in the aforesaid Clerk's Office, as amended with respect to Lot 18 on February 5, 2015, by an Amendment of record in Deed Book 10361, Page 624, in the aforesaid Clerk's Office (as amended, the "Subdivision Declaration").

WHEREAS, Section 2.2(a) of the Subdivision Declaration authorizes future Sections of the Development to be made subject to the Subdivision Declaration by a statement to such effect by Declarant on the subdivision plat for such additional Section which is filed in the aforesaid Clerk's Office and/or by filing a declaration to such effect in the aforesaid Clerk's Office.

Upon the filing of any such Declaration of Annexation, the term "Property" as used in this Declaration shall be automatically deemed modified to include and be a reference to such additional real property, unless otherwise specified therein.

WHEREAS, Spring Farm Lake LLC is the owner and developer of SPRING FARM LAKE Subdivision - Section 3 ("Section 3"), more particularly described as follows:

- 2. Declarant hereby declares, ratifies and affirms that Section 2 has been and continues to be subject to the Subdivision Declaration. As modified, the term "Property" in the Subdivision Declaration includes and refers to Section 2 and Section 3.
- 3. In all other respects, the Subdivision Declaration, as amended by the annexation and addition of Section 3, is hereby ratified and affirmed.
