

ARTICLES OF INCORPORATION

OF

STONEHENGE CONDOMINIUM APARTMENTS, INC.

The undersigned NORBERT C. NOPPER does hereby for himself, his associates and successors, form a non-profit Corporation, having no capital stock, under the provisions of Chapter 273, Kentucky Revised Statutes, and does hereby adopt the following Articles of Incorporation therefor.

ARTICLE I

The name of the Corporation is STONEHENGE CONDOMINIUM APARTMENTS, INC.

ARTICLE 11

The principal office of the Corporation is 245 Stonehenge Drive, Louisville, Kentucky, 40207. Norbert C. Nopper is the resident agent of the Corporation; his address is 245 Stonehenge Drive, Louisville, Kentucky 40207.

ARTICLE III

The objectives and purposes of this corporation is the control and management of the Horizontal Property Regime located at 245 Stonehenge Drive, Louisville, Kentucky, commonly known as Stonehenge Condominium Apartments, and the performance of all functions generally exercised by the management of a condominium project.

ARTICLE IV

The Corporation may acquire by purchase or otherwise, and may hold, maintain and manage such property as may be necessary for the management of the said condominium project, and may acquire, by purchase, or otherwise, individual apartment units in said condominium project as set forth in the Master Deed of the Horizontal Property Regime known as Stonehenge Condominium Apartments.

ARTICLE V

The executive authority of this Corporation shall be vested in a Board of Directors, which initially shall be composed of the following: Norbert C. Nopper, whose address is 245 Stonehenge Drive, Louisville, Kentucky, Monroe J. Cox, whose address is 2517 Plantside Drive, Louisville, Kentucky 40299; Sam W. Rayhill, Jr., whose address is 2517 Plantside Drive, Louisville, Kentucky 40299; Frank D. Crawley, whose address is 2517 Plantside Drive, Louisville, Kentucky 40299 and George-Joseph, whose address is 2517 Plantside Drive, Louisville, Kentucky 40299. The Board of Directors shall be elected at the annual meeting of the Corporation as specified in the By-Laws. The Board of Directors shall have the right to fill all vacancies on the Board occurring after election of members, even though the Director may not have assumed the active performance of his duties.

ARTICLE VI

The officers of the Corporation shall be a President, one or more Vice-Presidents, a Secretary and a Treasurer, and such other officers as may be deemed necessary by the Board.

ARTICLE VII

The By-Laws of the Corporation shall be prescribed by the members of the Board or Directors. When once adopted, they shall not be suspended except in the manner provided by said By-Laws.

ARTICLE VIII

The Corporation shall commence upon the filing of these Articles, and shall continue perpetually unless dissolved as provided by law.

ARTICLE IX

The private property of the members of the Board shall not be subject to the payment of the debts of the Corporation.
