

AMENDMENT TO THE MASTER DEED
AND DECLARATION OF HORIZONTAL PROPERTY REGIME FOR
THE STONEHENGE CONDOMINIUMS

THIS AMENDMENT TO THE MASTER DEED and horizontal property law for the STONEHENGE CONDOMINIUMS is made and entered into by Meredyth Thomas, President of the association, this 9th day of March 1999.

WHEREAS, The Stonehenge is a condominium regime organized and existing under the laws of the state of Kentucky and that certain Master Deed dated June 14th 1973 recorded in Deed Book 4633, page 468. In the office of the Clerk of Jefferson County, Kentucky; and,

WHEREAS, pursuant to of the By-laws of the association, 75% of the apartment owners having voted in favor of the provisions of this Amendment and this Amendment having been signed and acknowledged by all members of the BOARD.

NOW, THEREFORE, the By-laws of the association are amended in the following respects :

Notwithstanding any provision contained in the Master Deed or By-laws, from and after May 1, 1999, no apartment may be leased or rented and no apartment may be occupied by a tenant or other person who pays rent to the owner, unless the apartment owner held title to the apartment prior to May 1, 1999.

All other section, paragraphs, terms, provisions, and conditions of the Master Deed & By-Laws remain unchanged and are restated as if set out fully herein.

IN TESTIMONY WHEREOF, the President of the association states that this Amendment was adopted in conformity with the requirements of the By-Laws of the association at a duly called meeting of the association.
