Pursuant to the provisions of Section 273 261 of the Kentucky Revised Statutes, the undersigned nonprofit corporation adopts the following Articles of Amendment to its Articles of Incorporation, which were originally filed September 27, 1994 The amendment below was adopted by a majority of the directors and of the Village of Hartwick Residents Association, Inc ("Corporation") on the 17th day of October, 2001, in the manner prescribed by the Kentucky Charitable and Educational Societies Act

ARTICLE I

Article IV, 4 (e) of the Articles of Incorporation is amended to read as follows

ARTICLE II

(Article IV) 4. Purposes

(e) To provide for the painting of building exteriors, replacement of roofs and the maintenance and repair of streets, sidewalk, lawn and grass mowing of the property and landscaping of common areas and maintenance of all sanitary sewers from the Lot line of any Lot to the Louisville and Jefferson County Metropolitan Sewer District's Sanitary Sewer and Drainage Easement line
