Louisville, Kentucky 40222, has executed these Articles of Incorporation for the purposes of forming and does hereby form a Non-stock Non-profit corporation under the laws of the Commonwealth of Kentucky, in accordance with the following provisions.

#### ARTICLE I

## **NAME**

The name of the corporation is THE VILLAGE OF SPRINGMEADOWS CONDOMINIUM ASSOCIATION, INC.

## ARTICLE II

## **PURPOSES**

The general purpose of the corporation is to be the "CONDOMINIUM ASSOCIATION" as defined in the Kentucky Horizontal Property Law as amended, for the operation and administration of The Village of Springmeadows, a Condominium Project established in Jefferson County, Kentucky, pursuant to the provisions of the Kentucky Condominium Property Law.

#### ARTICLE III

#### **POWERS**

The corporation shall have all the powers conferred upon a Non-stock Non-profit Corporation organized under the provisions of Chapter 273 of the Kentucky Revised Statutes,

as amended; and all the powers conveyed upon the CONDOMINIUM ASSOCIATION, INC. under the Kentucky Horizontal Property Law as amended; all of the powers conferred upon the corporation in the Master Deed for The Village of Springmeadows Condominium Association, Inc., which document will be recorded by the Incorporator in the office of the Clerk of Jefferson County, Kentucky; and all of the powers necessary, proper, convenient and desirable in order to fulfill and further the purpose of this corporation.

# ARTICLE IV

#### **DURATION**

The corporation is to exist perpetually as long as The Village of Springmeadows Condominiums exists under the Condominium Plan of Ownership pursuant to the provisions of the Kentucky Condominium Property Law, unless the corporation is sooner terminated by the members in the manner provided in Chapter 273 of the Kentucky Revised Statutes.

#### ARTICLE V

## REGISTERED OFFICE AND REGISTERED AGENT

The registered office and the mailing address of the principle office of the corporation in the Commonwealth of Kentucky is 9310 New LaGrange Road, Louisville, Kentucky 40222, and the resident agent of the corporation in the Commonwealth of Kentucky is Michael A. # ARTICLE VI

## <u>MEMBERS</u>

All persons who are owners of the Units in Springmeadows shall be members of the corporation and the membership in the corporation shall be limited to such owners of such Units. Membership in the corporation shall terminate when a person or entity is no longer the owner of a Unit. Subject to the foregoing, admission to, and termination of Membership and the voting rights of members are more particularly governed by the Master Deed for The Village of Springmeadows Condominium and the By-Laws of this corporation.
