

AMENDMENT OF MASTER DEED AND DECLARATION  
OF HORIZONTAL PROPERTY REGIME

## WENDAMOOR CONDOMINIUM

We, the undersigned, representing more than seventy (70%) percent of the ownership interest of Wendamoor Condominium, described as follows:

BEING Tract B as shown on the minor subdivision plat attached to and made a part of the Deed of Record in Deed Book 5370, page 16 in the Office of the County Court Clerk of Jefferson County, Kentucky.

BEING the same property that is the subject of a Master Deed and Declaration of Horizontal Property Regime as set forth in Deed Book 5394, page 131 in the Office of the County Clerk of Jefferson County, Kentucky.

hereby amend the Master Deed only as follows:

Paragraph Eighteenth now recorded in Deed Book 5394 at page 149 in the office of the Jefferson County Clerk is hereby amended so that it reads as follows:

EIGHTEENTH: Except for the Commissary Unit and the Manager's Unit, all Units are restricted for occupancy by residents whose age shall not be less than forty (40) years of age except as may be permitted under Paragraph 8 of Article IV of the By-laws. The Commissary Unit and Manager's Unit may be used for occupancy by a resident manager or other employee or employees of the Grantor

or of the Association who need not be over the age of thirty nine (39) years; and said units may be used for any legitimate purpose.

We, the undersigned, hereby certify that this amendment was adopted by more the seventy (70%) percent of the ownership interest this 31 day of August, 1988.
